

Memorandum of Association

1. Name of the Society : **Uttar Pradesh State Rural Livelihood Mission (hereinafter referred to as "the Society")**
2. Address of the Society : The registered office of the society shall be in the office of the Commissioner, Rural Development, Government of Uttar Pradesh, 10th Floor, Jawahar Bhawan, Lucknow, Uttar Pradesh.
3. Area of the Society : The area of operation of the Society will be the entire State of Uttar Pradesh.
4. Objectives : The major objective of the Society shall be :-
 1. The Society shall function as the apex coordinating organisation for the implementation of the National Rural Livelihood Mission(NRLM).
 2. To act as a dedicated and specialized nodal agency for implementing and monitoring the schemes aimed at generating remunerative employment and alleviating poverty in rural areas.
 3. To develop such strategies or facilitate implementation of such schemes that ensures sustainable income and livelihood for the rural poor.
 4. To endeavour for bringing about convergence amongst all such schemes and interventions that facilitates empowerment of the rural poor and other vulnerable segments.
 5. To contemplate necessary interventions which consolidate and strengthen Self Help Groups(SHG) of rural poor.
 6. To promote such interventions that ensure sustainable increase in income of rural poor, create additional opportunities of self employment for them through skill development/up gradation programmes.
 7. To seek active and effective involvement of Panchayati Raj Institutions(PRIs) as and when required achieving inclusive growth in rural areas.
 8. To effect synergy amongst various programmes implemented by the Central Government and Government of Uttar Pradesh to mitigate poverty in rural areas.
 9. To initiate all such actions and participate in all such interventions that may appear necessary or incidental in implementation of the project and in particular for the achievement of the objectives of the society.


